The Hon'ble National Company Law Tribunal (NCLT) vide its order dated 3rd March 2021 approved the scheme of merger of two promoter entities namely Suremi Trading Pvt Ltd and Sushriprada Investments Pvt Ltd (hereinafter referred to as the Transferor companies) with the Company. In terms of the said scheme 3,11,17,689 equity shares of Rs 10/- each were allotted to the following shareholders of the said transferor companies (hereinafter referred to as the Promoter shareholders) by the Amalgamation Committee (constituted by the Board of NOCIL Ltd) on 30th March 2021:

The above referred equity shares of the promoter shareholders were allotted on 30th March 2021 and hence the requisite steps for listing and dematerialization of the said shares could be filed /initiated by the Company only after that date. The said shares are expected to be dematerialized on receipt of requisite approvals from the Depositories.
